Planning application: Seave Green House, Chop Gate, NYM/2019/0625/LB RESOLVED: The Parish Council has no objection to this planning application but a comment was submitted that the Parish Council hopes that the new windows will have a similar appearance as the existing ones, albeit, double glazed.
